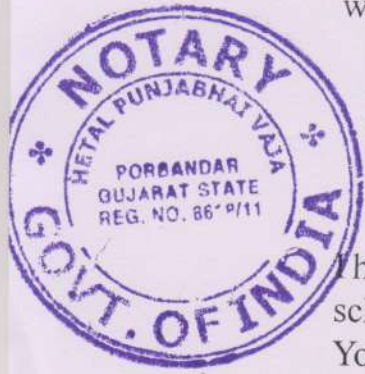
Permission is given to Managing Trustee, Secretary Shree Birla Sagar Higher Secondary School, Porbandar Mandal, Shree Birla Sagar Higher Secondary School, Porbandar to open High School of Std. 8th Eighth only one Standard with the following conditions.

1. --
2. If Trust : Society is not registered, Then Register it before approval of the School.
3. To keep Lakdi Item, Educational tools, Physical training tools and tools of Drawing & Industry.
4. To develop various libraries for Teacher & Student and to keep enough stock of books.
5. To provide the facilities of play ground.
6. Trained Graduate will be having degree of B.T. or B.Ed. & who have educational experience of five years in High School. From this three years experience required after training, Post training experience such teacher should be appointed as Principal. Moreover to appoint teacher of science, Hindi, Physical training, P.E., Drawing and other subjects and other trained Teachers should be appointed under the rules of Grant-in-aid code.
7. The rate of fee should be according to the department decided. If rate of fees have to be increased, then to take prior permission of the Department.
8. The School Director has to give undertaking to follow the rules of Department and direction given by the Government time to time. The education officer has to get this undertaking and keep it into office.
9. Education Officer has to verify the building of school before beginning the school. Especially building should have full light and air and should have healthy atmosphere and rooms should have required area.
10. After beginning the school and after observing the Department only, the issue of giving approval to the School will be considered. School has to give report to the Education Officer about when school started ? Whether the requirements of furniture, building, staff, number of Student etc. are fulfilled ?



11. As per rule 3,3 of Grant-in-Aid Code, School has to follow the rules of Approval. After verifying it only, Grant will be given to the School.
12. Mandal has to open the standard for which permission is given by the Department. Do not open additional or further standard. However if it will be opened permission of such additional standard will not be given and the whole responsibilities will be of Mandal.
13. Education Officer has to send the report about how much requirements have been fulfilled by the School Manager, and where actually the school opened within Dtd.31/06/70.
14. Provident Fund Scheme should be entered at the time of beginning of the School.
15. School has to give salary to the Employee regularly.
16. If School will be started as per course of Gujarat State with the condition to follow the rules of Department. And if the numbers of pupil will not enough, Grant will not be given. By this Condition permission of Std.8th with English Medium is given.
